7R00 (.....S) (1Z) (Special train) will **run as arranged by ARTC to pass** Islington Junction 1009 hours, ARTC North Boundary 1010 R, Woodville Junction 1011, arrive Broadmeadow 1012 hours, forms **7R01** 1030 hours.

7R01 (.....S) (1Z) (Special train) will depart **UR** Broadmeadow 1030 hours **XM**, pass Woodville Junction 1031, **DISL**, ARTC North Boundary 1032, pass Islington Junction 1033 hours, **thence run as arranged by ARTC.** forms **7R02** 1514 hours.

7R02 (.....S) (1Z) (Special train) will **run as arranged by ARTC to pass** Islington Junction 1514 hours, ARTC North Boundary 1515 R, Woodville Junction 1516, arrive Broadmeadow 1517 hours, forms **7R03** 1527 hours.

7R03 (.....S) (1Z) (Special train) will depart **UR** Broadmeadow 1527 hours **XM**, pass Woodville Junction 1528, **DISL**, ARTC North Boundary 1529, pass Islington Junction 1530 hours, **thence run as arranged by ARTC.**

SPECIAL INSTRUCTIONS

- **The Rail Motor Society** will arrange suitably qualified operating crews.
- Train consist details will be submitted via DTPOS by **The Rail Motor Society** on a Train Manifest form to all relevant Control offices prior to departure from each originating point.
- The special trains will be comprised of vehicles and locomotives listed in the Train Operation Conditions Manual or the Train Operating Conditions Waiver to the appropriate maximum timing load, length and speed for each section.
- Station / Duty Managers and Officers In-Charge at stations concerned are to note only customers in possession of tickets issued by **The Rail Motor Society** will be permitted to join and travel.
